Registration Information

Registration Fee: \$55.00 per child

The Registration fee is non-refundable. Space is limited and payment is required at time of registration.

Program Rates (All rates include: Breakfast, Lunch, Snack, & most field trips.)

Weekly: \$70.00/child \$68.00/for additional children*

Fees are charged by the week even if attendance has only been one or two days. Fees are to be paid on Friday.

The additional children discount only applies to households with more than one child in the Program. One child will be charged the regular weekly fee and all additional children will be charged the additional children discount. **THE CHILDREN MUST BE IN THE SAME HOUSEHOLD IN ORDER TO GET THE DISCOUNT.*

Field Trips

Most field trips are included in the program fee; the parent will be notified about the trips that are not covered in the program cost and will require a field trip fee that must be paid by the parent or guardian. **All Field Trip dates and times will be announced.**

Dress Code:

On field trip days, please send your child to program in a pair of sneakers to help prevent needless injuries.

T-Shirts that contain suggestive language, pictures or obscene language are not to be worn in the program. Sleeveless shirts or T-Shirts, shirts that expose the flesh or reveal the midriff are also not to be worn.

Shorts must be at an appropriate length. High cut shorts are not to be worn.

Please refrain from sending your child to the program in baggie pants; they have a tendency to get caught on objects very easily. Belts are to be worn so pants will not hang low or fall down.

Please do not send your child to the program in open toe shoes. We will have a number of indoor/outdoor activities daily. Children whose feet are not properly enclosed may have to sit out during certain activities.

Injuries:

It is in our best interest that your child is in the safe and healthy environment. We make it our business to take the extra precautions to ensure your child's safety. However, if your child is injured; the program or church is not liable for the injuries.

Personal Items:

We ask that parents please make sure that your child does not bring any valuable items. This includes any electronic devices, games, etc., to ensure that the items are not lost, stolen, or broken.

Drop Off/Pick Up Information

The building will be open from 8:30 am until 4:30 pm. The staff will stay until 4:45 pm without any additional charge. After 4:45pm there will be an additional \$15.00 charge every 15 minutes. The payment is due when you pick-up your child. **(Example: 4:30 pm - 4:45 pm - No charge) (4:46 pm - 5:00 pm - \$15.00 Late Charge)** If someone else is assigned to pick up your child the same policy will apply. **All children must be picked up no later than 5:00 pm. At which time it becomes the responsibility of the Program to contact the Department of Social Services.**

Passes:

The summer program will be issuing three pass cards to each parent or guardian. Only persons with a pass card will be allowed to pick-up your child. If the person picking up the child does not have a pass card, their name must be listed on the emergency contact form or the child will not be released. No exceptions will be made.

If your child's emergency contact information changes, it becomes the responsibility of the parent/guardian to contact the summer program at least 24 hours in advance.

Virginia Statute: § 18.2-138. Damaging public buildings, etc.; penalty.

Any person who willfully and maliciously (i) breaks any window or door of the Capitol, any courthouse, house of public worship, college, school house, city or town hall, or other public building or library, (ii) damages or defaces the Capitol or any other public building or any statuary in the Capitol, on the Capitol Square, or in or on any other public buildings or public grounds, or (iii) destroys any property in any of such buildings shall be guilty of a Class 6 felony if damage to the property is \$1,000 or more or a Class 1 misdemeanor if the damage is less than \$1,000.

Any person who willfully and unlawfully damages or defaces any book, newspaper, magazine, pamphlet, map, picture, manuscript, or other property located in any library, reading room, museum, or other educational institution shall be guilty of a Class 6 felony if damage to the property is \$1,000 or more or a Class 1 misdemeanor if the damage is less than \$1,000.
